 Bio-solids: Deep soil sampling finished last week. Trees: 30 acres planned. Seeing fewer, but
 larger sites. Grass: 200 acres of CRP planned for next year. Gevik Site: Sign changes and kiosk in
 process. Ditches will be cleaned out and filled in. Entenman mentioned that according to water
 tests that have been run, the Gevik Site greatly reduces the E. coli level in water flow before it
 gets to Wall Lake. Water Festival: Schools, presenters and donors are being lined up.
 Scott and Mary DeWitte were chosen for the Izaak Walton Conservation award. Ceremony will be
 held on November 26th.
